After graduating cum laude from Cornell University, Dr. Hale received her medical degree from NYU where she was elected to Alpha Omega Alpha. She was also the recipient of the American Medical Women's Association Citation and the Marion Sulzberger Dermatology Award at NYU. Dr. Hale served as chief resident at The Ronald O. Perelman Department of Dermatology at NYU and was selected to receive the Morris

Leider award for Excellence in Dermatology.

Dr. Hale has extensive experience in the field of skin cancer and is a long-time advocate for increasing public awareness of the disease. As a senior vice president of The Skin Cancer Foundation, she frequently volunteers her time on screening initiatives and public speaking events about the early detection and treatment of skin cancer. She also lectures extensively on the treatment of photoaging with the latest advances in lasers and injectables.

This year, Dr. Hale was again named a New York Super Doctor, as published in *The New York Times Magazine*, a Castle Connolly Top Doctor and one of New York Magazine's Best Doctors. Dr. Hale has received the Surgical Attending of the Year Award from NYU's dermatology residents and the Alpha Omega Alpha Honor Medical Society teaching award, which is given annually to one NYU voluntary faculty member for his/her dedication to teaching. In her short tenure, Becky has enjoyed connecting on a new level with physician members, skin cancer patients, donors and corporate partners, as she shares her ideas for the future of the Foundation.
